

GIFTS OF MARKETABLE SECURITIES/SHARES TO ST. THOMAS UNIVERSITY

Donor procedure to initiate gifts of marketable securities/shares:

St. Thomas University is grateful to accept donations of marketable securities that are traded on a recognized stock exchange (e.g., TSE, NYSE). **Please note** that neither St. Thomas University nor the CIBC Wood Gundy office can initiate this transfer on your behalf.

A charitable receipt for income tax purposes will be issued by St. Thomas, in accordance with CRA guidelines, to reflect **the value on the day of trading that the University's stockbroker receives the securities** in negotiable form.

Please carry out the steps below to ensure the completion of your gift.

1. **Contact** your personal broker / transfer agent to request the electronic transfer of specified marketable securities as a donation, and provide St. Thomas University's broker information (CIBC Wood Gundy).
Your broker will need to contact St. Thomas University's broker directly, citing the account number (noted below) to effect the transaction.
